*U.S. News & World Report* has ranked the University of South Carolina's Darla Moore School of Business No. 1 in international business, making this the 16<sup>th</sup> consecutive year the school has claimed the top spot. The school, which ranked in the Top 50 overall among the best undergraduate business programs in the country, finished ahead of New York University, the University of Pennsylvania's Wharton School, the University of Michigan and the University of Texas-Austin in the international business category. In the first-ever ranking of public university honors colleges, the South Carolina Honors College was ranked No. 1, according to the soon-to-be published guide, A Review of Fifty Public University Honors Programs. The ranking is based on honors curriculum, honors retention and graduation rates, honors housing, study abroad programs, and priority registration. The 275-page book, to be published in April, is intended to be used as a guidebook for prospective college students. It reviewed honors programs at all public universities ranked in the top 75 nationally as well as those public universities that are members of the Association of American Universities. Established in 1978, USC's Honors College enrolls 1,400 students and is known for leadership and service learning, research and internship opportunities, in addition to a curriculum that emphasizes cutting-edge thinking and problem-solving skills. In 2009, a new, LEED-Gold certified honors residence hall with suite-style rooms and meeting space opened. The average SAT score of last year's incoming class was 1427. The University of South Carolina is among the nation's best values for public higher education according to Kiplinger's Personal Finance magazine. USC ranks 35th on Kiplinger's annual list of 100 best values in public colleges. The ranking cites four-year schools that combine outstanding education with economic value. Kiplinger's assesses quality according to a number of measurable standards, including the admission rate, the percentage of students who return for sophomore year, the student-faculty ratio and the four-year graduation rate. The HealthGrades report found that patients treated at five-star rated hospitals experience a 73% lower risk of mortality and a 63% lower risk of complications compared to one-star rated hospitals. In addition to being the Best Hospital in the Midlands for Joint Replacements-a region that includes Calhoun, Fairfield, Kershaw, Lexington, Newberry, Orangeburg, Richland, and Saluda counties-Newberry Hospital is ranked third best hospital for joint replacements in South Carolina, according to HealthGrades. Newberry Hospital also received Five Stars for Total Knee and Total Hip Replacement in 2012.

The Columbia, SC Metropolitan Statistical Area ranked 37<sup>th</sup> best medium sized city for Job Growth.
